

# Privacy Policy

Menzies School of Health Research (ABN 70 413 542 847) (“Menzies”) is a charity registered with the Australian Charities and Not-for-profits Commission, and is dedicated to improving the health and wellbeing of Indigenous Australians. Menzies built the AIMhi Stay Strong app (SERVICE) to improve the reach and utilisation of digital mental health supports, particularly in rural/remote areas and with Indigenous people. While the app is available for sale there is no Commercial model or intent. All revenue generated is used to further Menzies’ charitable objectives. This SERVICE is provided by Menzies and is intended for use as is.

This page is used to inform website visitors regarding our policies with the collection, use, and disclosure of Personal Information if anyone decided to use our Service.

If you choose to use our SERVICE, then you agree to the collection and use of information in relation to this policy. The Personal Information that we collect is used only for providing and improving the SERVICE. We will not use or share your information with anyone except as described in this Privacy Policy.

## **Information Collection and Use**

For a better experience, while using our SERVICE, we may require you to provide us with certain personally identifiable information, including but not limited to name, email address, camera access, username, password. The information that we request is will be retained by us and used as described in this privacy policy.

The SERVICE requests permission to access your camera only if you choose to use the functionality available to include a photo in the app. This information is not collected by Menzies, it is only stored locally on your device.

The app does use third party services that may collect information used to identify you.

## **Log Data**

We want to inform you that whenever you use our Service, in a case of an error in the app we collect data and information (through third party products) on your phone called Log Data. This Log Data may include information such as your device Internet Protocol (“IP”) address, device name, operating system version, the configuration of the app when utilizing our Service, the time and date of your use of the Service, and other statistics.

## **Cookies**

Cookies are files with a small amount of data that are commonly used as anonymous unique identifiers. These are sent to your browser from the websites that you visit and are stored on your device's internal memory.
